

I. Goodbye, American Dollar - Hello, New Global Currency!

Finally, plans created in 1969 to gradually replace the American Dollar as the international currency are moving into a final phase.

As we have stated before, the demise of the Dollar is planned and will occur without collapsing the

economy.

"The most common argument made in the mainstream against a global currency taking shape is the argument that no other currency in the world today has the strength or widespread circulation necessary to replace the dollar as a primary reserve unit. This is true, if, you only look at separate currencies, and not the big picture."

"The reality is, central banks and the IMF have no intention of replacing one national currency with yet another national currency as the world reserve. What they DO intend to do, however, is replace the dollar with a basket of national currencies linked together and homogenized under a single unit."

For years, Cutting Edge has been stating that the plan for an international currency to replace the Dollar would revolve around a "basket of currencies" because we literally believed this part of the Illuminati plan when we read it. When was this plan initiated?

"A global currency, or at least the foundation for one, already exists in the form of "Special Drawing Rights" (SDR's), created by the IMF in 1969 ... as paper collateral used to replace gold as the primary means of international trade between governments and central banks without the need for Forex exchanges .. Today, the asset has morphed into a trade mechanism representing a basket of currencies, and, a tool to displace the U.S. dollar as the world reserve currency."

Therefore, the American Dollar has been targeted since 1969 for eventual replacement as the international reserve currency. Forget all those rumors that a single currency is

going to replace the Dollar; the plan from the beginning is to replace the Dollar with the SDR (Special Drawing Rights).

Already, the IMF is issuing SDR's to foreign countries rather than Dollars or any other foreign currency. The concept of an SDR as currency is so foreign to most Americans that they will not object to their precious Dollar being slowly and gradually sent to the dustbin of history so that the SDR can replace it.

Within the United States, of course, people will still be using Dollars as our medium of exchange, unless the American Dollar has also been replaced by the AMERO, the currency of the North American Union!

Get ready, also, for ratings agencies to systematically downgrade the American credit rating in the world, and do not be scared. This rating system will not cause the American economy to collapse, but will so frighten Americans that they will be more readily agreeable to the North American Union and its currency.

What are the changes still to be made which will occur before the Dollar is replaced on the world scene?

- 2) Standardized Exchange Tables For The SDR Must Be Put In Place
- 3) The SDR Must Be Made Indispensable To Global Markets
- 4) China Must Be Given Membership In The SDR
- 5) China Must Decouple Completely From The Dollar
- 6) The Dollar Must Be Removed As The World Reserve Currency

As we contemplate the role of the United States in this post-Dollar world, we must turn to some basic understandings:

We believe that all the <u>"Functioning Core"</u> nations will be the ones experiencing this prosperity until the horror of God's judgments begin falling right after the mid-point.


