I just left a meeting with Kim Davis in the Carter County Detention Center where she is being held. Following the meeting, the Liberty Counsel legal team working on Kim's case held a press conference where I told the members of the press...

"Kim made it clear to me that she has no intention to resign. She will continue to serve the people of Rowan County as she has done for so many years. She will never violate her conscience and never betray her God. She is prepared for the consequences of those two decisions – and that's why she's here."

Kim is being held in cell 151. At this point, she will not be able to spend Labor

Day weekend with her family outside the jailhouse walls.

As she was sentenced yesterday, Kim told Judge Bunning, "God's moral law conflicts with my job duties. You can't be separated from something that's in your heart and in your soul."

Everyone, whether you agree with Kim or not, should be inspired by her strong convictions and resolve!
